This document provides a first simple example of usage of the package IBMPopSim, for simulating a human population with birth and death events. See vignette('IBMPopSim') for a detailed presentation of the package.

# 1 Example description

We consider a population in which individuals are characterized by their age and gender (male or female).

Individuals can give birth (only if female) or die. Birth and death intensities depend on the individuals' age and gender, but stay constant over time. In this toy model, birth and death intensities are fitted to England and Wales' 2014 birth and death rates (source: Office for National Statistics).

# 2 Population creation

The initial population is created from a 100 000 individuals data frame sampled from England and Wales' 2014 age pyramid distribution (source: Office for National Statistics).

### 3 Model parameters

Birth and death rates are fitted to England and Wales' 2014 birth and death rates.

## 4 Events creation

There are 2 possible events :

- Birth
- Death

Both event intensities are of class individual, which means that the intensity at which an individual gives birth or dies only depends on his age and characteristics, and not on other individuals characteristics (in other words, there are no interactions).

The birth and the death intensities are bounded step functions, which are constant over time.

#### Outputs

sim\_out\$population is an object of class ?population given by a data frame composed of all individuals who lived in the population over the period [0,50] (the individuals in the initial population and those born during the simulation period). Each line corresponds to an individual, with his date of birth , date of death (NA if still alive at the end of the simulation) and gender.

The function **?age\_pyramid** returns an object of **?pyramid** class containing the age pyramid of a population at a given time.

# 6 Different simulations with the same model

### 6.1 Change of initial population

The population evolution can be simulated starting from a different initial population, without having to recompile the model.

#### 6.2 Modify an intensity

Events intensities and/or kernels can be modified without recompiling the model, simply by changing the parameters value.

In the first toy model, mortality rates are assumed to be constant after age 90, with a maximum age of 120 in the population. This leads to a significant increase in the number of individuals of age over 100, even though mortality rates don't change over time in this model.

A more realistic assumption is to assume that mortality rates increase after age 90, by changing the model parameters death\_male and death\_female. The two step functions are replaced by functions of type ?piecewise\_x, composed of a step function before age 90 and a linear function for older ages.

The modification of the shape of mortality rates for ages over 90 generates a decrease of about 10% (depending on the simulation) in the individuals aged over 100 after 50 years of simulation.

The number of children by women can be recorded by adding a new characteristic (here named children) and changing the birth event kernel code.

# 8 Addition of "cause of death" characteristics

In order to model different competing causes of death, several death events can be created, each modeling one cause of death.

#### 8.1 Model with two independent causes of death

Individuals can die from two main causes of death 1 and 2, supposed to be independent. Then, the death intensity at age a is

$$\mu(a) = \mu_1(a) + \mu_2(a),$$

where  $\mu_i(a)$  is the death intensity at age a associated with cause i.

This model can be simulated with two death events associated to cause 1 and 2, and adding a new characteristic recording the cause of death.
